Advice on registering your boat with ANT is enclosed and fees are shown in the enclosed 'Licence Information for Boaters' leaflet. This registration form must be used to apply for a Registration Certificate for the Avon (covering the River Avon from Alveston Weir to its confluence with the River Severn). All boats afloat on the Avon must comply with the boat safety scheme, be insured against third party risk, ANT recommends at least £3000,000 cover including salvage costs, and display a current registration certificate. Please complete ALL UNSHADED boxes, sign and return the form below with the fee and supporting documents in the envelope provided, making the cheque payable to 'ANT'. If paying by bank transfer please use boat name as reference and date this form the same date as payment made. Thank you
