LICENCE TERMS & CONDITIONS

ALL CRAFT moored on, or using for any purpose whatsoever, or for whatever period any part of the Avon, including that part upstream from its confluence with the Severn, all marinas, basins and back waters must display a current licence. Private licences do not cover boats that are hired out, used for commercial gain or reward. Please contact the office for commercial applications.

THE ANNUAL licence is valid for the River Avon from Alveston Weir to the confluence with the Severn at Tewkesbury. There are two licence periods available; 1 January to 31 December or 1 July to 30 June. The licence is not transferrable from one craft to another. No refunds are given for boats sold or leaving the navigation, the annual licence remains with the craft. All craft

navigation when not in use. **BOAT SAFETY SCHEME:** A current BSS certificate must be provided unless exempt. The Boat Safety Office will provide details of exemptions.

THIRD PARTY INSURANCE: All craft (powered and unpowered) must be insured. ANT recommends at least £3m cover including salvage cover. Copy of current certificate must accompany all annual registration forms.

TENDER: A Private licence covers one tender which must be, unpowered, 15' long or less, in the same ownership, identified as 'Tender to (parent vessels name)' and can be carried either on davits or on the parent vessel.

<u>CRT CONTINUOUS CRUISING CRAFT:</u> Can only apply for a short term licence, maximum 30 days.

RESIDENTIAL BOATS (as per bye-law 30b): Any boat occupied for residential purposes for an aggregate period of more than 6 weeks in any one year must apply annually for permission with their licence application form, and will be subject to an annual extra charge in addition to the annual private licence fee. A residential licence will then be issued. The boat MUST have an approved, flood safe, serviced permanent mooring.

HOUSEBOAT Defined as an unpowered, static, permanently moored boat with living accommodation for residential* or pleasure use. Licence calculation: Length x Width in metres x £45.00. *Residential supplement applies if applicable (see table). Prompt discount less 50%.

WIDE BEAM Defined as a craft 3M / 10' beam and over, wide beam canal boat, barge or Dutch style barge.

RECEIPT: A receipt will be issued if the office cannot issue the licence due to insufficient documentation and a request for further information notified. NO licence will be issued until documents are received.

NON REGISTRATION: If necessary, the Trust will take legal action against boat owners who fail to pay their licence fees and they will be subject to debt recovery action through the courts. In addition, boat owners who make no attempt to register or to satisfy the BSS and insurance requirements are liable to legal action. CONCESSIONARY LICENCE May be applied for by riparian owners for unpowered craft under 15ft, rescue craft and non-commercial workboats. Proof of insurance & BSS certificate will be required. Contact the office to apply for a concessionary licence.

HOW TO APPLY:

Option 1: Online www.avonnavigationtrust.org/licences. Payment can be made securely on website.

Option 2: Fill out the ANT Annual Registration Form and post or email a clear copy of both sides to the Trust office and make payment using one of the payment methods below:

Cheque: Made payable to 'ANT' with application form.

On-Line Banking: Sort Code 20 98 61 Account 63227529 use boat name as reference. **Send application form in advance** and date the form same as payment date.

Telephone: Please email or post application form before calling to make payment. We cannot call you to take payment.

Licences cannot be issued without a signed application form, website applications do not require a separate form.

PROMPT DISCOUNT APPLICATIONS, must be purchased either before 28/02/25 for January start or 31/07/2025 for July start or before launch or joining the navigation and ALL REQUIRED DOCUMENTATION AND PAYMENT must be received otherwise the FULL FEE will apply. If a valid BSS certificate is provided within 2 months following the licence due date the 50% prompt discount will be refunded. This allows you time to arrange a test and pass certificate. All craft afloat must apply and pay for a licence, including non compliant boats.

EARLYBIRD JANUARY DISCOUNTS: Applications must be received before 31/01/25 (Jan start). To take advantage of the Early bird discounted price ALL REQUIRED DOCUMENTATION AND PAYMENT must be provided otherwise the FULL FEE will apply as above.

<u>ELECTRIC OR STEAM</u> powered craft, 40% discount will apply.

CRT RECIPROCAL LICENCES. The Trust has reciprocal licensing arrangements with Canal & River Trust. A boat owner with an annual ANT licence and a permanent mooring on the Avon can purchase a discounted reciprocal, 3,6,9,or 12 month CRT long term licence at 20% discount for canals & rivers or rivers only. A boat owner with an annual CRT licence and a permanent mooring on CRT waters can purchase a discounted reciprocal annual ANT licence at 20% discount as shown in the table of charges. Proof of permanent mooring and CRT licence will be required.
